Sworn Affidavit

David L. Jarvis, of Arlington, Texas, personally came and appeared before me, the undersigned Notary Public, and makes this his statement, testimony and General Affidavit under oath or affirmation, in good faith, and under penalty of perjury, of sincere belief and personal knowledge that the following matters, facts, and things set forth are true and correct, to the best of his knowledge:

- On 7-15-23, I submitted a public information request to the AISD Legal Office for the following documents: the title and publisher of all materials used by AISD (from Jan 2022 to June 2023) to inform/train AISD employees and/or students in the following areas: gender identity/confusion; transgender issues generally; and gender affirming care. I also asked AISD to produce a copy of any AISD written guidance given to AISD counselors on how to handle counseling in these same areas.
- 2. On 7-27-23, Paralegal Aaron Boals (with the AISD Office of General Counsel) responded to my July 15 document request (PIA 2022-23_498). In his response, Mr. Boals did not produce documents responsive to my request in that he did not identify the publisher of these materials or the name of the company providing this training to AISD. However, he did provide what appeared to be screen shots of three training sessions with the following titles: "Making Schools Safe and Inclusive for Transgender Students"; "Making Schools Safe and Inclusive for LGBTQ+ Students"; and "Title IX and Gender Equity in Athletics".

- 3. On 7-27-23, I emailed Mr. Boals and asked him how I was able to view the actual contents of the three courses identified in his July 27 email. Since Mr. Boals did not provide any documents relating to AISD guidance to AISD counselors in these areas, I also asked Mr. Boals "Are you saying that AISD gives no written guidance to counselors in these areas to maintain some form of consistency in guidance given by AISD counselors in these areas?"
- 4. On 7-31-23, Mr. Boals responded to my July 27 email by stating: "The Texas Public Information Act does not require the District to answer questions. The records released are those responsive to your request."
- 5. On 8-10-23, (in view of Mr. Boals' inadequate-response) I sent an email about this matter to AISD Interim Superintendent Dr. Steven Wurtz and to the AISD Board of Trustees (the Board). In this Aug 10 email, I asked Dr. Wurtz the following two questions:
 - How am I able to view the documents (lesson plans, hand-outs to students, etc.) used to provide the actual training summarized in the three pages attached in the PDF document marked "Non-Mandatory Training" (also referenced in paragraph 2 of this affidavit)?
 - Since Mr. Boals provided no documents to me which provide guidance to
 AISD counselors about how to counsel AISD students or employees in the
 areas of gender identity/confusion; transgender issues generally; and gender
 affirming care I asked Dr. Wurtz the same question "Are you saying that
 AISD does not provide any written guidance to AISD counselors in these three

areas -- to maintain some form of consistency in guidance provided by AISD counselors in these areas?"

In this same email, I informed Dr. Wurtz (and the Board) that if Dr. Wurtz failed to respond to my questions by 8-18-23, I planned to file a formal grievance. The basis of the grievance would be a formal public complaint about the disturbing lack of transparency and honesty demonstrated by both Dr. Wurtz and the Board in response to questions relating to these very sensitive gender issues - matters of great importance to both AISD parents and taxpayers.

- 6. On 8-31-23, I sent an email to both the Board and Dr. Wurtz reminding them of my intention to file a formal grievance. Neither the Board nor Dr. Wurtz have responded to either my email dated 8-10-23 or 8-31-23. In my Aug 31 email, I also pointed out to both Dr. Wurtz and the Board that their current position of refusing to answer simple questions about AISD guidance to counselors "undermines public trust and strongly suggests that you are willfully concealing information from AISD parents and taxpayers."
 - 7. Section 11.1512 (b)(3) of the Texas Education Code requires that the Board and the Superintendent <u>"work together</u> to provide educational leadership for the district...". (my bold) The refusal of both the Board and Dr. Wurtz to respond to my questions reflects a disturbing failure of their educational leadership responsibilities to AISD parents and taxpayers.
 - Section 11.201(a) of the Texas Education Code states that "the superintendent is the educational leader and the chief executive officer of the school district". Section

11.201(d)(1) of the Texas Education Code states (in part) that the "duties of the superintendent include assuming administrative responsibilities and leadership for the planning, organization, operation, supervision, and evaluation of the education programs, services, and facilities of the district". (my bold)

- 9. The refusal of both the Board and Dr. Wurtz to respond to my two simple questions (see paragraph 5 of this affidavit) reflects a deeply troubling failure of their leadership responsibilities to AISD parents and taxpayers. On the Board's website, they state that they see themselves as "guardians of the public trust". Truly a noble goal – but why should the public trust the Board when the Board refuses to trust the public with the truth – with honest and responsive answers to these two questions?
- 10. If the AISD Board of Trustees believes any statements in this affidavit are not accurate or are misleading/incomplete, please inform me and I will take appropriate action as needed to revise this affidavit.


